Abstract

The purpose of this study was to describe the causes of dysfunction in the realization of the role of village assistants in Biatan Lempake Village, where the main roles and tasks of village assistants have been regulated in Law No. 6 of 2014 and what obstacles were present in community assistance in Biatan Lempake Village which included quality, coordination, accessibility and also cultural aspects in Biatan Lempake Village, Biatan District, Berau Regency.

The method used in this study is a qualitative method by observing, structured interviews, and documentation. The results obtained from this study are that there are several aspects that are a factor in the dysfunction of the role of village assistants in Biatan Lempake Village. The first aspect is that the district, sub-district and village parties did not socialize or introduce the role of village assistants, then the second from the village assistants themselves did not approach the government of Biatan Lempake Village and also the people of Biatan Lempake Village, and the last was in Biatan Lempake Village still views the character of a person where the assistants who are currently serving are people who are still very young and are considered not to have too much influence on Biatan Lempake Village.

The role of the village assistant that has been established through Law No. 6 of 2014 is expected to be able to assist the village government in receiving facilitation from someone who serves as a village assistant. However, this is not the case in Biatan Lempake Village, because it is constrained by a lack of understanding as a result of no socialization regarding the roles and duties of a village assistant. There are inhibiting and supporting factors from the dysfunction of the role of village assistants, namely supporting factors including accessibility where the assistance location is the
