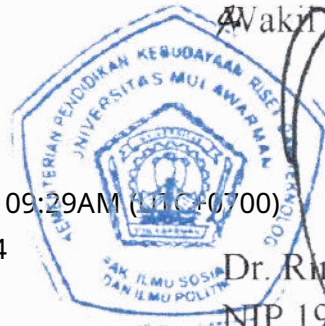

This research focuses on comparing the use of village-specific financial assistance budgets between RT 03 and RT 05 in Rebaq Rinding Village, as well as analyzing the factors that influence differences in budget use. The research also observed compliance with the use of special village financial assistance budgets in the two RTs based on regency regulation Number 61 of 2023 concerning special Financial Assistance to Villages. The data collection technique used is through purposive sampling technique. The results of this research show the development and empowerment at the RT scale in Rebaq Rinding Village refers to Regent Regulation Number 61 of 2023 concerning Special Financial Assistance to Villages which includes the availability of RT operational vehicles, obstacles in operationalizing the Admintrak through the Aman RT application, obstacles in making and updating RT maps and profiles, the absence of training and increasing the capacity of community groups within the RT environment, the existence of community social services and activities as well as social religious activities, as well as improving the community economy through mutual cooperative practices to help poor communities.
